Supply and replacement of Guy wire:

- 1. supply of Stainless steel Guy wire 10 mm of Usha martin or equivalent (300 mtr) with misc G.I. Nut bolt, Thimble, D shakle, Tumbkle etc. to complete the replacement guy for 30 mtr guy mast at Jind (Haryana) (30 mtr).
- 2. Replacement of Guy wire with proper care and safety.
- 3. Measurement of verticality and correction if required.

N.B:

- The work is to be carried out during Non-Transmission hours, with prior consultation and approval with the Engg. head.
- 2. All the tools required for the work should be provided by the contractor and shall not be loosely carried but in a bag.
- 3. Contractor is responsible for following the safety precautions of his men engaged in the work.
- 4. The contractor will indemnify and hold the indenter harmless against compensation if any due to unforeseen happenings during the execution of the work & he shall abide by the work compensations act in force.
- 5. The successful Contractor has to enter in to an agreement with this office on placement of work order and the work should be executed as per the agreement terms, procedure / specifications attached with the Work Order.

- (i) Successful bidder shall ensure that all the works are carried out as per schedule of work in time. All the mast climbers should be provided with ISI standard safety belt and men at work site should be provided with safety helmets by the tenderer. In case of any mishaps at site, AIR will not be responsible for any lapse in safety.
- (ii) Should any defects be noticed in the workmanship and/or workmanship of any material supplied by the bidder, within the guarantee period it shall be carried out by the tenderer free of cost to the consignee. All India Radio shall inform the tenderer about the defects noticed. On receipt of such intimation, the supplier shall depute their personnel to investigate the cause of defects and to attend the problem immediately. Taxes and duties of any kind what ever imposed by the authorities shall be borne by the tenderer. Dismantled material including tools/materials required for works shall be the sole responsibility of contractors even though these are stored inside AIR premises till handing over to station
- (iii)The contractor shall insure his men while working at AIR site, against any injury, accidents death etc. Similarly, the equipment, instruments, tools etc., belonging to the contractor shall be insured against damage, loss, theft etc. The contractor shall identify and hold harmless the purchase against all claims in respect of injury to any person however arising out of the work in the course of such installation. The contractor shall discharge his entire obligation under the Indian Workmen Compensation Act in a sit affects workmen in his employment.

GENERAL TERMS AND CONDITIONS FOR SMOOTH EXECUTION OF WORK AT SITE: -

- 1. All Tools, plants, implements, winch machine, labour and supervisors, as required, to be provided by the bidder. Bidder has to provide necessary insurance of the labour at his own cost before commencing the supply. Proper safety measure to be adhered by the bidder in respect of materials and manpower.
- 2. Other working systems should not be damaged causing disruption of ongoing Transmission. Any damage caused to the property at site while carrying out the work has to be made good by the Bidder at his own cost.
- 3. The bidder shall complete and include all minor/major items and accessories which may not have been enumerated in this scope of supply but which are useful and necessary for completion of supply at his own cost.
- 4. Prior approval of the purchaser, in writing, shall be obtained, if the bidder desires to sublet or assign any section of the work associated with supply. Such permission of consent shall not, however discharge the bidder from his liabilities in this contract or any part thereof.
- 5. The bidder shall make his own arrangements for the storage of materials and their safe custody at site for the entire SUPPLY.
