

Subject:- Quotation Rates for short term Cab and Taxi hiring service.

Dear Sir,

Please furnish your quotation for short term cab and taxi hiring services as per following terms & Conditions:-

1. The rates shall be quoted in the prescribed Performa only.
2. The tenders so submitted will be valid for a period of one year from the date of awarding the contract. This period can be extended by the undersigned.
3. The tenders should be addressed by name to the undersigned in sealed covers and should reach this office latest by **1500 hrs. on 30-07-2024**. The envelope with sealed cover should mention quotation opening date and subject of quotation.
4. The quotation will be opened in the office of the undersigned at **1600 hrs. on 30-07-2024** in the presence of such tenderers or their representatives whatsoever.
5. The undersigned reserves the right to reject any tender without assigning any reason.
6. The vehicles deployed under this contract should be commercial/ Taxi permit. The service provider shall submit to the department certified copies of RC books and comprehensive insurance policies to this effect.
7. The service provider shall have a PAN/ AADHAR card issued by the Government of India, (self attested photocopy to be attached). The service provider shall have a GST registration number issued by the Central Excise/ Service Tax Department (self attested photocopy to be attached). They should produce copy of returns filed by them under the respective Acts during the past three years.
8. The service provider shall have experience not less than two vehicles to any central/state government department or a public sector undertaking in the last three years. The service provider shall submit proof of providing such service.
9. The service provider shall also provide driver in addition to vehicles provided through tender under contract and all responsibility of driver will lie on service provider.
10. The vehicles should be on the service provider. The successful bidder should produce, registration of documents within 7 days of the award of contract.
11. The vehicles shall not be older than 3 years (manufactured on or after 2020) and not run more than 50000 KM.
12. The service provider shall not have been blacklisted by any organization for unsatisfactory performance. An undertaking to that effect shall be submitted by the service provider.
13. Misbehaving/Smoking/Chewing of Tobacco, if Complained by any official against the driver strict action will be initiated as per contract.
14. The registered office of the tenderer must be situated in Jalandhar.
