TERMS AND CONDITIONS:

- The Enlistment of Bidder should be valid on the Last date of Submission of Bids.
- In case the Last Date of Submission of Bid is extended, the Enlistment of Bidder should be valid on the Original Date of Submission of Bids.
- Interested bidders shall be required to submit copy of all documents required for issue of quotation paper along with original Documents for Verification. Original documents shall be returned after verification.
- The rates to be quoted by the bidder shall be firm and inclusive of all taxes including 18% GST.**
- The bidder shall ensure that benefit of Input Tax Credit (ITC) of GST on materials likely to be availed by them is duly considered while quoting rates.
- Income Tax, TDS towards GST, Labour Cess & other statutory deductions etc., shall be made at source as per the prevalent laws**
- (A) List of Documents to be produced in office of EE(E), CCW, AIR, Guwahati for issue of quotation documents:
 - Valid electrical license and Supervisor license with up-to-date validity.
 - Certificate of Registration for GST and acknowledgement at upto date filed return as per NIT Stipulation.
 - The intending bidder should have satisfactorily completed any kind of HT / LT electrical works during the last seven years ending last day of the month previous to the one in which the tender is invited.

(a) Three similar work each of value not less than 40 % of the estimated cost put to tender

Or

(b) Two similar work each of value not less than 60 % of the estimated cost put to tender

Or

(c) One similar work of value not less than 80 % of the estimated cost put to tender
(at least one of them should be in Central Govt./ Central Autonomous body/State Govt./State Govt. Undertakings)

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum, calculated from the date of completion to the last date of receipt of application for tender.

7. (B) The last date and time of receipt of application for issue of quotation paper is upto 01.30 PM on 01.07.2024. The last date and time for issue of quotation paper is upto 02.00 PM on 01.07.2024

The last date and time of submission of bid is upto 03.00 PM on 01.07.2024 in the office of EE(E), CCW, AIR, Guwahati

8. The time allowed for carrying out the work will be 01 (one) month from the next day of issue of work order.


9. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their quotations, the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender / bid. A quotationer / bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The quotationer / bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a quotation by a quotationer/bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

10. The work in general shall be carried out as latest CPWD book of specifications and IS code.

11. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other tender / bid and reserves to itself the authority to reject any or all the quotations / bids received without the assignment of any reason. All quotations in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer / bidder shall be summarily rejected.

12. The bids will be opened in the office of EE(E), CCW, AIR, Guwahati at 03.30 PM on 01.07.2024. Interested participants may participate during the opening of quotations.
