

The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <https://prasarbharati.eproc.in> free of cost.
5. E.M.D. deposit declaration can be seen in the CPWD -6 for e-tendering.
 - (a) **e-Tender Processing Fee** as applicable shall be payable to M/s. C1 INDIA PVT. LTD. through their e-gateway by credit card/ debit card, internet banking.
 - (b) Detailed procedure can be seen in the CPWD -6 for e-tendering.
6. Those contractors not registered on the website mentioned above, are required to get registered before hand. If needed they can be imparted training on online bidding process as per details available on the website.
7. The intending bidder must have **valid class -III digital signature** to submit the bid.
8. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
9. Contractor can upload documents in the form of JPG format and PDF format.


