Tender will be opened at 3.30 P.M. on 11.03.2025 in the office of Executive Engineer ©, CCW, AIR, at 4th floor Doordarshan Bhawan, Kolkata-700095.

Special Conditions for contractors :- Contractors as well as specialized agencies who have the definite proof from the appropriate authority of having successfully completed,

- a) One similar completed work costing not less than 88.50 lakh during last 7 years, **or**
- b) Two similar completed works each costing not less than 66.50 lakh during last 7 years, **or**
- c) Three similar completed works each costing not less than 44.50 lakh during last 7 years.

Similar work means:- Demolition of RCC and Steel Structures.

If EMD found in order then 1st envelop of technical bid will be opened. The financial bids shall be opened only if document of 1st & 1st envelops shall be found in order.**
