TERMS & CONDITIONS

Name of Work: ARMO E&M services at DDB Tower-B, Mandi House, New Delhi. (SH: SITC of 4.5 TR Tower type AC in MSR room)

1. The work shall be carried out strictly in accordance with CPWD specifications for Electrical Works 2013 (internal) and 1995 (External) as amended upto date and in accordance with Indian Electricity Rules, 1956, Indian Electricity Act, 1910 as amended upto date and as per instructions of the Engineer-in-Charge including as below and nothing will be paid extra.
2. Any damage done to the building during the execution of electrical work shall be the responsibility of the electrical contractor and the same will be made good immediately at his own cost to the satisfaction of the Engineer-in-Charge. Any expenditure incurred by the department in this connection shall be recovered from the contractor and decision of the Engineer-in-Charge about recovery shall be final.
3. The contractor shall make his own arrangement at his own cost for electrical/ general tools and plants required for the work.
4. All the materials to be used on the work shall be got approved by the Engineer-in-charge or his representative, before use. The rejected materials should be removed from the site immediately failing which Engineer-in-charge will get it removed at the risk and cost of the contractor.
5. The watch and ward of the installation is the responsibility of the Contractor till the work is completed and handed over. The Contractor will have to make their own arrangement for stores.
6. Bad workmanship in the opinion of Engineer-in-charge shall not be accepted and shall be rectified at contractor's cost to the entire satisfaction of Engineer-in-charge.
7. Dismantling of control accessories/ equipments shall be within the scope of the work and nothing extra shall be paid on this account. The dismantled material as per credit item shall be removed from site only with the permission of engineer in-charge or concerned JE (E).
8. The contractor shall take all precautions for safety of the workman. If any accident/mishap occur, the department shall not be responsible for the same. Consequently any compensation payable shall be at the contractor's cost.
9. All the debris of the electrical works should be removed and the site should be cleared by the contractor immediately after the occurring of debris.
10. The work can be terminated at any time without assigning any reason by the department.
11. In case the contractor fails to attend the work in time, work will be executed at his risk and cost and same will be recovered from his bill as per actual expenditure. The decision of Engineer-in-charge is final and binding on the firm.
12. The rates quoted should be inclusive of GST.
13. The entire installation shall be at the risk and responsibility of the contractor until these are tested and handed over to the department.
14. The contractor shall make his own arrangement for storage of materials either brought by him or issued to him by the department.
15. Approved make- (a) Tower AC- Voltas/Lloyd/Daikin/Mitsubishi/Blue star/ carrier.
16. If the agency failed to complete the work within stipulated period of completion a recovery @3000/per day shall be made from their bill.
