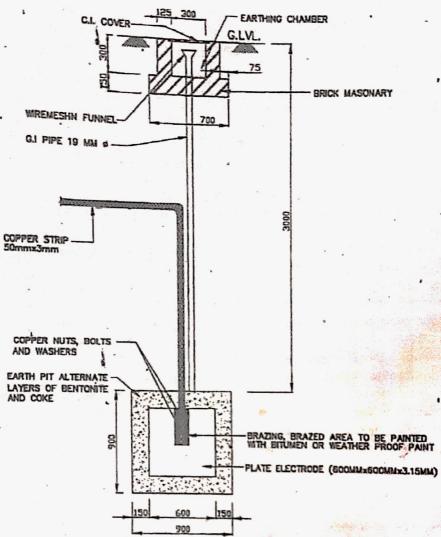

Name of the Work: Supply, fabrication and construction of copper plate earth pits- 02 Nos. having earth resistance of less than 1 ohm, as per the details given below:-

Pit size of 1000mm x 1000mm (at bottom) x 10ft. deep (or more) is to be excavated & Copper plate of Size 600x600x3 mm is to be placed vertically in the excavated Pit. The plate shall be connected to copper strip of 25mmx3mmx5 mtr. length by brazing and using brass bolts, nuts, check nuts & washers. Copper purity should be of 99.9%. The pit to be filled with alternate layers of 80kgs of charcoal & 80kgs. of raw salt in alternate layers up to a depth of 900 mm & remaining portion to be filled with fresh loose soil without stones preferably black cotton soil. The job includes providing of 1½ x1½ x1 (height) elevated brick chamber at ground level with neat finish/plastering with a hole in the middle to pass the 10ft. long Class B G.I. pipe of 48 mm dia. having minimum 10mm holes at every 6" length with a provision for funnel at the top. The funnel shall be fixed with wire mesh. The chamber to be provided with FRP/G.I. manhole frame & cover.

- 1. Bid document contains certain conditions for Manual submission of tender and are now redundant. Document shall be deemed to have been modified to that extent. Page No. shall be given on each and every paper/documents serially uploaded in the technical by bidders, Bidders shall ensure to quote rate of each item. If any cell is left blank and no rate is quoted the rate of such item shall be treated as "0" (zero). The Earnest Money shall be in the form of ST ENG PBBCI DD KUBAND EARTHST payable at New Delhi. However exemption we will be given to the firms registered with MSME.
- 2. The items / facilities desired for short duration (2-6 days) absolutely on hire as per norms enlisted under DGS&D and other applicable /accepted Norms of Government of India and amended time to time.
- 3. The duly authorized committee by competent authority may like to inspect the warehouse (s) and/ or other places (s) as identified by the entity for getting inspected the facilities and equipment before finalization of technical evaluation process of received bids.
- 4. The operators / essential crew members must be the minimum, restricted to quantity that is fully mandatory and absolutely essential for full operation of hired equipment. The personal should be properly trained and have sufficient experience and exposure in related field in major international/ national events. The operators / crew members should be at the sole responsibility of bidder firm and his contract with firm should be abiding to the applicable labor laws of the Republic of India. - 5. The firm shall be solely responsible if the Hired equipment gets damaged during its usual predefined usage as per its manual or due to mishandling by its operator provided by firm or due to any unnatural calamity or act of God. In all such case the firm (Bidder) cannot file any case of Arbitration for compensation of any kind on Doordarshan. No compensation will hence be made for the equipment damaged during the time of coverage/recordings or at the time of transportation whatsoever be the may reasons. However if during the regular, scheduled use of Hired facility there is loss to camera/Manpower of Doordarshan due to poor workmanship or manufacturing defect in Hired equipment the firm shall be liable to give compensation as per Independent internal enquiry committee setup by Doordarshan or Legal proceeding in Delhi /NCR.
- 6. In case of any dispute between the successful bidder (firm/company) and Prasar Bharati arising out of in relation to this Contract, the dispute shall be referred to a sole Arbitrator to be appointed by Prasar Bharati. Any decision of such Arbitrator shall be conducive and binding on both the parties. The arbitration proceedings shall be held at Delhi and shall be governed by the provisions of the Arbitration and Conciliation Act, 1996, as amended from time to time. The Courts

of Delhi will have jurisdiction over all legal disputes arising out of or in relation to this Contract.

- 7. The successful bidder shall be required to submit a security deposit/performance guarantee equivalent 3% of Contract value in the form of FDR drawn in favor of DDO, DTH ES Todapur, New Delhi or Bank Guarantee valid for three months within 3 days of the award of the contract. The quotation should specifically mention rates for Supply & Taxes separately. In case of Quotation of F.O.R Station of dispatch basis, the purchaser will not pay separately transit insurance and the supplier will be responsible until the stores arrive in good condition at the destination. - 14. If any tenderer withdraws his tender before the expiry of the validity period, or before the issue of letter of acceptance, whichever is earlier, or makes any modification in Terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit The earnest money absolutely. This provision would naturally apply only to the lowest tenderer once the earnest money of all the tenderer except those of the lowest is refunded as per provisions.

- 16. MANUAL/TELEFAX/e-MAIL offers, received directly by this organization, will not be considered. In case tender opening date falls on a holiday, the bids will be received and opened at the same specified time on next working day. Bids received late or submitted after the scheduled specified time on scheduled date will not be entertained and will be returned back unopened.
- 17. The purchaser may, at his discretion extend the deadline for the submission of the bids by mending the bid document, in which case all rights and obligations of the purchaser and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended.

- 19. Performance Guarantee (as per Annexure: 4): Successful Bidder needs to submit Security Deposit of 3% of contract Value only as stated above in the Tender Document.
- 20. Payment of Entry Tax / Octroi Duty and Toll Tax (on ultimate products): As the material, which is to be transported to the consignee, belongs to the Government of India /Prasar Bharati and therefore is exempted from Entry Tax / Octroi Duty / Toll Tax. However, if the State Governments / Statutory Local Bodies are bound to levy such taxes, the taxes will be paid by supplier / contractor. Supplier / Contractor may raise its claim, for reimbursement of such duties / taxes paid, with Organization, along with original receipt of the payment.
- 21. GST liable and intended to be claimed from the purchaser should be distinctly shown along with prices quoted. Where this is not done a claim for GST will be admitted at any later stage and on any ground whatsoever.
- 22. Printed terms and conditions of tendering firms will not be considered as forming parts of their tender.
- 23. The Bid submitted shall remain open for acceptance for a period of 180 days.
- 24. **RIGHT OF ACCEPTANCE**: The undersigned reserves the right to reject the lowest tender or all the tenders after assigning reasons whatsoever. Further, the undersigned reserves himself the right to increase or decrease up to 50% of the quantity of goods and services specified in the schedule of the requirement without any change in the unit price of the order quantities or other term conditions at the time of award of contract. All Quotations/Tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected. The competent authority on behalf of President of India reserves the right of accepting the whole or any part of the Tender shall be bound to perform the same at the rate quoted. Canvassing whether directly or indirectly, in connection with Tender/quotation is strictly prohibited and the Tender/quotation submitted by the Contractors / suppliers who resort to canvassing will be liable to rejection.

## 25. FAILURE AND TERMINATION CLAUSE

Time and date of delivery shall be essence of the contract. If the Contractor / Supplier fails to deliver the stores, within the period fixed for such delivery in the schedule or at any time repudiates the contract before the expiry of such periods, the purchaser may without prejudice to any other right or remedy, available to him to recover demur-rages for breach of the contract:-

- a. It may further be noted that the liquidated demur rages on the cost of contract price of delayed/No supplies (whole unit) at the rate of 10% of issued order value from outstanding of firm to this office or directly debit able from security deposit with intimation to the firm and liability to be black listed from any further tender in future
- b. Cancel the contract or a portion there of by serving prior notice to the Contractor/Supplier and if so desired purchase or authorize the purchase of the stores not so delivered not carried out, or others of a similar description (where stores not delivered not carried out, exactly complying with particulars are not in the opinion of the purchaser, which shall be final readily procurable) at the risk and cost of the Contractor/Supplier. If the Contractor/Supplier had defaulted in the performance of the original contract, the purchaser shall have the right to ignore his tender for risk purchase even though the lowest, where the contract is terminated at the risk and cost of the firm under the provisions of this clause, it shall be in the discretion of the purchaser to exercise his discretion to collect or not, the Performance Guarantee from the firm on whom the contract is placed, at the risk and expense of the defaulted firm.

## 26. FORCE MAJEURE:

- a. If any time during the continuance of the contract the performance in whole or in part by the contractor shall be prevented or delayed by reason of any war, hostility acts of the public enemy. Civil commotion, sabotage, fires, floods, explosions, epidemics, Quarantine restrictions, strikes, lock-outs/lockdown or acts of God (therein after restrictions refer to as events and provided notice of happenings of any such eventuality is given by the contractor within 21 days from the date of occurrence thereof, the purchaser shall by reason of such event, neither be entitled to cancel this order not shall have any claim for damages against the contractor in respect of such non-performance or delay in performance and delivery shall be resumed as soon as practicable after such events have come to an end or ceased to exist.
- b. Provided further that if the performance in whole or part or any obligation under this order is prevented or delayed by reasons of any such event for a period exceeding 180 days, the purchaser and the contractor shall meet to find a neutral agreement to any effect resulting the reform or the purchaser may at his option cancel order provided also if the order is cancelled under this clause, the purchaser shall be at liberty to take over from the contractor at order prices all unused, un- damaged and acceptable

material bought out components and stores in course of manufacture in the possession of the supplier at the time of such cancellation.

- 27. **CANCELLATION:** The purchaser reserves the right to cancel the order in the event of non-performance/ delay in execution of the work or unsatisfactory performance by the contractor and recover payment already made if any, along with losses/ damages incurred.
- 28. **GENERAL**: All the pages of the tender document should be duly signed, stamped and serially numbered on submission, failing which the tender may not be considered as qualified tender.
