As the requirement is time bound, contractor / supplier should have to follow the instructions given by this office. Contractor / supplier should have to be guaranteed for working of Jimmy Jib provided at the given site, if due to any reasons Jimmy Jib fails to provide Proper video Signals at the given site, it is sole responsibility of the contractor / supplier & any extra cost should be borne by the contractor / supplier.

#### I. PRICE & STATUATORY DUTIES:
