- 2. Information and instructions for bidders posted on website shall form part of bid document.
- 3. The bid document consisting of plans, specifications, schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from the website <a href="https://prasarbharati.eproc.in/">https://prasarbharati.eproc.in/</a> free of cost.
- 4. But the bid can only be submitted after depositing Processing Fee in favor of M/s. C1 India Pvt. Ltd and deposition of original EMD in the division office of Executive Engineer(E) CCW, AKASHVANI, PB(IPSB), Nagpur-01 or division office of any Executive Engineer (C/E), Civil Construction Wing, Akashvani, within the period of bid submission (The EMD document shall only be issued from the place in which the office of receiving division office is situated) and uploading the mandatory scanned documents such as Insurance Surety Bonds, Account Payee Demand Draft or Banker's Cheque or Fixed Deposit Receipt from any of the Commercial Banks towards EMD in favor of Executive Engineer (E), CCW AIR PB(BCI), Nagpur-01, receipt for deposition of original EMD to the Executive Engineer (E), CCW, AKASHVANI, PB(IPSB), Nagpur-01 or division office of any Executive Engineer (C/E), Civil Construction Wing, Akashvani, within the period of bid submission and other documents as specified. The FDR shall be accepted only if it is valid for a period of six months or more after date of opening of the Tender.
- 5. Detailed procedure can be seen in the CPWD-6 for e-Tendering
- 6. Contractors, who are not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the said website
- 7. The intending bidder must have valid Class-III Digital Signature to submit the bid.
- 8. On the date of opening of the Bid, the bidder can login and see the bid opening process. After opening of Bids he will receive the competitor bid sheets.
- 9. Bidder can upload documents in the JPG or PDF format.
- 10. SC/ST bidders enlisted under Class-V category are exempted from processing fee of e-Tender payable to M/s. C1 India Pvt. Ltd.
- 11. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in yellow color and the moment rate is entered, it turns light grey. If any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO). However, if a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above/below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer
