

#### H. GURANTEE TERMS:

The supplier should provide warranty / guarantee for minimum one years and onsite support. Any parts failing during the guarantee period shall be repaired /replaced free of charge by the supplier at the installation site.

#### I. Qualification Criteria

- 1. Bidder should have experience of minimum three years in the field of maintenance of A. C. plant and cooling tower. Details of experience must be enclosed.
- 2. The bidder should have valid GST / PAN number. It is required to mention GST/ PAN number and must enclose copy of the registration without which bid would be rejected.

#### J. PRICE & STATUATORY DUTIES:

- 1. It should be mentioned specifically whether the price quoted includes all taxes and duties.
