II. SPECIFICATION:

A) FEATURES:

- i)Flooring material should be highly homogeneous with a high PVC content pressed into compacted floor covering in sheet with Design, colour dyed as a raw mixture to ensure even colour throughout the thickness and a matt finish.
- ii)Its surface must be densely compacted for improved wear and ease of Maintenance.
- iii) It should be treated with polyurethane special maintenance treatment obtained by UV laser crossing-linking to avoid staining of chemical products, anti-bacterial hand gel, etc. in order to increase the durability of the flooring.
- iv). It should have excellent resistance to everyday wear and tear in high traffic area and does not require the application of acrylic polishes.
- v). It should have a protective wear layer.

C.INSTALLATION PROCEEDURE:

- 1) Removal of existing floor mat/tile of the proposed studio without damaging the existing flooring .The removed floor mat /tiles are to be dumped at a place shown by the Engineering Head away from the building.
- 2) The surface must be made free of dust, dirt and other barrier materials such as grease, paint, water and adhesive residues. Suitable commercially available materials have to be used to clean the floor. Suitable mechanical methods have to be adopted to provide a roughened clean sound open porous surface.
- 3) As per direction and the entire satisfaction of Engineer-in-charge Flooring sheet has to be fixed.

- 1. All the above works have to be carried out in presence of I.O/Station Head at Akashvani, Calicut and Akashvani ,Bhadravathi
- 2. The above works have to be carried out within 45 days from the date of issue of Supply/Work order.

- 4. Terms of Payment: 100 % Payment on completion of work.

- 9. GUARANTEE / WARRANTY PERIOD:
 - The Work shall be guaranteed for a period of 1 **Year** from the date of Commissioning Any failure in the work carried out, during the Guarantee period shall be repaired / replaced free of charge by the Contractor at the Site.
- 10. Both your PAN and GST Number should be definitely indicated in your quotation.

vii).Flooring Material should be protected with proper treatment so that application of Wax or polish is not required during its life time. Also it should act as a barrier against Stains and chemical aggression.

- 11. Taxes: GST leviable and intended to be claimed from the purchaser should be distinctly shown along with prices quoted. Where this is not done no claim for GST will be admitted at any later stage and on any ground whatsoever.
- 12. The contractor shall make his own arrangement for storage of all equipment and materials brought to site from time to time and their safe custody at site till they are taken over by the indenter/his representative. The contractor shall make his own arrangement for providing accommodation for his workmen at site.
- 13. The contractor shall make his/her own arrangements for procuring necessary labour, skilled and unskilled. He should conform to all local government laws and regulations covering labour and their employment.
- 14. The contractor and his employees shall comply with the regulation in force for the controlled entry into premises where work is being carried out.
- 15. Contractor liable for damage caused during installation work and imperfections noticed.
- 16. The contractor shall indemnify and hold harmless the purchaser against all claims in respect of injury or life to any person howsoever arising out of the work in the course of such installation/work. The contractor shall discharge his entire obligation under the Indian Workmen Compensation Act in as for as it affects workmen in his employment.
