Terms and Condition

1. Delivery period & Guaranty period must be mentioned. The prices should be firm and given as under:-
 - a. The unit price of the item should be clearly indicated in the tender.
 - b. Prices quoted should be F.O.R. destination in Tura and inclusive of all charges as packing, customs etc. wherever applicable.
2. In case of Quotation of F.O.R. Station of dispatch basis, the purchaser will not pay separately transit insurance and the supplier will be responsible until the stores arrive in good condition at the destination. Tender / Quotation in which transit insurance has been specified by the firm as an additional item of expenditure is liable to be ignored.
3. Mandatory Documents required with quotation
 - a. GST No. should be clearly mentioned.
 - b. PAN No. should be clearly mentioned.
 - c. HSN Code of item is mandatory.
4. Only Printed terms and conditions of tendering firms will be considered. Firm has to follow all the terms and conditions as mentioned in the tender enquiry by the purchaser. Conditional Tender will not be accepted.
5. The quotation should be sent in a sealed cover addressed to the undersigned, The Assistant Director (Engineering) Akashvani, Tura, Dakopgre, West Garo Hills Meghalaya - 794001 so as to reach on or before 16-06-2025 at 02:30 PM.
6. Estimated cost Rs.60,000/- (Sixty Thousand) Approx.
7. THE COVER SHOULD BE SUPERSCRIBED WITH THE FOLLOWING:
 - a. Works for which quotations are enclosed.
 - b. Reference to letter of enquiry.
 - c. Due date of opening quotation.The quotation will be opened in this office at 3:30 PM . 16-06-2025 in the presence of the tenderer or their agents such as they may choose to attended.

8. QUOTATIONS NOT PROPERLY SUPERSCRIBED WILL NOT BE CONSIDERED.

The quotations submitted shall remain open for acceptance for a period of 90 (Ninety) days from the date of opening of the Tender . In case tender opening date falls on a holiday, the Bids will be received and opened at the same specified time on next working day will not be entertained and will be rejected / unopened. The purchaser may, at his discretion, extend the dead line for the submission of the bids by amending the bid document, in which case all rights and obligations of the purchaser and bidders previous subject to the dead line will thereafter be subject to the deadline as extended.

9. TERMS OF DELIVERY OF STORES: The delivery of the entire stores at this office shall be completed within 30 days from the date of placement of order or as mentioned in the purchase order. The powers extension of delivery period are vested with the sanctioning authority.

10. TERMS OF PAYMENT: The payment of the materials will be made only after receiving the materials in good physical condition or after testing the goods in the circuit.

11. Both your PAN (Permanent Account Number) and TIN (Tax Identification Number) should be definite indicated in your quotation.

12. Any type of tax which is applicable shall be mentioned separately in the quotation. Where this is not mentioned claim for any type tax will not be admitted any later stage and may not be granted whatsoever.



The unit rate quoted on the tender shall be applicable for the quantity for which order is place . All Tender / Quotation in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to rejected . on the physical appearance of the materials during supply, if it is realized that rates quoted by the firm are not justified then the justification for the same can be asked.

14. Canvassing whether directly or indirectly, in connection with Tender / Quotation is strictly prohibited and the Tender / Quotation submitted by the Contractors /Suppliers who resort to canvassing will be liable to rejection.


