

Additional conditions for passenger lift repairs by the Original Equipment Manufacturer (OEM) .

1. Adherence to CPWD Specifications:

- The repair work must be carried out according to the CPWD's General Specifications for Electrical Works (Part-III), Lift & Escalator-2003, including any amendments.
- This includes adhering to the specific standards and guidelines outlined in the CPWD documents for electrical work and lift-related installations.

2. Providing Tools and Spare Parts:

- The OEM is responsible for providing all necessary tools and special tools for the repair work.
- All materials and spare parts required for the repair, including those listed in Annexure-A (Inclusion in Comprehensive AMC), should be included in the scope of the contract.

3. Other Considerations:

- The contractor may need to provide drawings, electrical wiring details, and operation manuals before commencing work.
- Any necessary civil work, such as minor repairs or alterations, may also be the responsibility of the contractor.
- The OEM should also ensure that the work is carried out with the utmost care to avoid any damage to the building's infrastructure, and any damage should be repaired by the contractor at no extra cost.

4. Additional Specifications (May Vary):

1. The manufacturer may need to be registered as a Class 'A' manufacturer with the Central CPWD.
2. They may need to demonstrate satisfactory completion of similar projects with a certain value as per CPWD manual.
3. The manufacturer may also need to have experience in the field of supply, installation, testing, and commissioning of lift works for a period of seven years.
4. The lift manufacturer shall comply with BIS standards, duly certified by the manufacturer itself.
5. The manufacturer shall be compliant to the Public Procurement (Preference to Make In India), Order 2017 (as amended from time to time) issued by the Department of Industrial Policy and Promotion (DIPP), Ministry of Commerce and Industry.
6. The experience of successful completion of similar works shall be as per CPWD Works Manual/SoP. The manufacturer shall furnish an undertaking regarding availability of spares for the entire expected life of the lift i.e. 15 to 20 years.


7. The complete lift installation including its components, safety devices, various types of controls etc., testing, inspection, operation & maintenance shall conform to relevant Codes, Standards, code of practices, guidelines, safety rules, inspection manual(s), rules issued by Bureau of Indian Standards, as amended up to the last date of receipt of tenders.

8. Quality standards shall conform to latest IS/ISO-9001:2015.

9. The agency shall be available at all times and communication by Telephone/e-mail/fax to the agency shall be acknowledged immediately on the same day.

- 10. Maintenance of the repaired lift by the OEM for a period of not less than one year, after successful completion of the work without any extra cost. This may include regular inspections, maintenance checks, and necessary repairs to keep the lift operating safely and efficiently.

11. The down time of repaired lifts being maintained by the manufacturer shall not be more than 8 hours (average) in case of minor faults and 7 days (average) in case of major faults.
