- 1. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he consider himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website https://prasarbharati.eproc.in free of cost.
- i) But the bid can only be submitted after depositing processing fee in favour of C1 India Company" through their e-gateway provision.
- ii) Uploading the mandatory scanned documents such as Demand Draft or pay order or Banker's cheque or Deposit at call receipt or fixed deposit receipts and bank guarantee of any scheduled bank towards EMD in favour of respective Executive Engineer and other documents as specified.
- iii) The amount of EMD can be paid by multiple Demand Draft/Pay Order /Banker's Cheque /Deposit at call receipt/FDR's along with multiple Bank Guarantee of any schedule bank, if EMD is also acceptable in the form of Bank Guarantee.
- iv) Detailed procedure can be seen in the CPWD -6 for e-tendering.
- 4. Those contractors not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
- 5. The intending bidder must have **valid class-III digital signature** to submit the bid.

- 6. On opening date, the contractor can login and see the bid opening process.
- 7. Contractor can upload documents in the form of JPG / PDF format.
- 8. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".

Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
