- 2. Date of opening of pre financial bids(Technical; Bids): 09.06.2025 at 04.00PM
- 3. Date of opening of financial bids 12.06.2025 at 04.00PM.
- 4. The sale of tenders (Physical Copies): against a cost of Rs.236/- incl. 18% GST up to 09.06.2025 12.0 clock noon.

Validity of rates:

The firm has to quote rates that shall be deemed valid for a period of 180 days and in case of any extension in the validity of the rates, the same shall be subject to mutual consent of the station and the qualified tenderer.

Award of Tender:

Deputy Director General (E), Akashvani Jammu is the competent authority for award of tender.

The acceptance of the quotation for competitive purpose (i.e., for Bidding purpose) shall be subject to terms and conditions as laid in the relevant annexure (attached with the quotation inviting letter). Deputy Director General (E) reserves the right to reject any of the quotation or all of the quotations without assigning any reason thereof.

- 1. Copy of the GST registration certificate of the contractor/ firm. (Indicating GST number as well)
- 2. Copy of PAN for the purpose of income Tax Deduction at source.
- 3. The Cancelled cheque leaf of the current Bank account on which the firm is maintaining its commercial transaction.
- 4. Registration certificate of the contractor/ firm certifying the trade profile of the contractor.
- 5. A Bank draft of 5,000/- issued in favour of the bidder and pledged to DDO, PB AIR-Jammu. (as EMD). However the EMD amount is exempted in respect of contractors coming under the category of MSME as per the guidelines of Government of India.
- 6. An Affidavit duly signed by the deponent and attested by the notary affirming the genuineness of documents and also as to affirm on that the firm has never been blacklisted by any government of India department for any breach of agreement or default/ panellized for non execution/sub standard execution of work.
- 7. Experience Certificate at issued by any Government owned PSU or any Department of J&K Government or Government of India. (Minimum 02 successful execution of repairs works of civil electrical nature of the tune of Rs.2,00,000/-.)
- 8. Turn Over Certificate indicating a minimum threshold commercial financial transaction as per certified balance sheet for Rs.10 lakh.

Terms & Condition TERMS AND CONDITIONS

- 1. The qualifying firm shall have to deposit a security amount of Rs.10,000/-. in the form of Term Deposit of one year drawn in favour of the firm/ contractor. The same has to be pledged to the DDO, PB AIR Jammu with the validity of two years from the date of issuance. A Bank Guarantee in the matter is also acceptable in lieu of the Bank term Deposit.
- 2. The security amount shall be released after three months on successful completion of the contract.
- 3. The firm shall be responsible for handling any unforeseen disability, electrocution, snake-bite, animal attack to any of its Labour, while execution of the work at site. An agreement covering the above aspect has to be furnished by the contractor in the form of indemnity bond of Rs.100/-denomination.
- 4. The firm/ contractor or any of its labour (including heirs, legal appointed successors or any other close relation) won't claim any compensation like that of Govt. Job/ continuation of the contract, ex-gratia or financial entity in case of any mishap/ injury/ death while execution of the work from the department, neither as matter of compassion or for sustenance.
- 5. The firm/ contractor shall arrange for all types of tools, implements, Power tools, stair-case, protective gear for safe execution of the work. All norms of industrial safety shall be followed.
- The competent authority can prematurely call-off the contract without assigning reason thereof. The contractor shall be paid on pro-rata/ proportionate basis on pre-mature termination of the contract. If the competent authority decides to do so or if the required funds are not available with the office.
- 7. The materials required for execution of the job shall be pre inspected for quality and quantity and specifications etc. The pre inspection report shall be an essential document for final acceptance of bill for payment (subject to post verification also).
- 8. The contractor shall have to work under the supervision of Engineer on duty from the office side and no deviation/alteration or reduction in quantity shall be allowed to the described scope of work.
- 9. The work has to be executed as per the standards best in the industry and follow all the relevant guidelines as laid in Indian Electricity rules 2005 with amendments later on.
- 10. The materials used should be of standard brands and as far as possible having ISI / ISO certification.
- 11. All the materials as mentioned in the annexure shall have to be provided and laid as per the sketch excepting following items shall be provided by the department:

- a. 1500VA Inverter (Semi sine wave output)
- b. 150 AH led acid 12V DC batteries. 02nos
- c. Battery trolly
- 12. All the applicable deductions like that of income tax TDS, GST TDS, educational cess shall be made by the DDO on the verified amount of the bills and credited in the respective GST accounts and PAN of the contractor.
- 13. The contractor shall ensure that labour engaged by the contractor for execution of the work is in good state of health and above 18 years of age but below the age of 58 years.
- 14. The contractor shall have to seek security permission and provide ID- proofs as well as address proofs of the labourers engaged by him.
- 15. The contractor shall follow all the guidelines as laid in the labour rules and no disputes in this regard shall be acceptable by the department. Any complaint in this regard shall be acceptable by the department. Any complaint in this regard shall be dealt under relevant provisions of the law/labour rules/ departmental procedures of redressing grievances and shall be subject to jurisdiction of Jammu courts.
- 16. After opening of the price bids, if the Lowest Bid (L-1) rate is found substantially higher than the estimated cost or available budget, Department will cancel the procurement process/ reject all Bids; Re-Tender will be invited afresh after detailed scrutiny of the estimated cost.
- 17. If the quoted rate for Bid, is found considerably lower than the estimated rates, it will be considered as abnormally low Bid; in such cases, Department may seek written clarification from the Bidder, including detailed price analysis of its bid price in relation to scope, schedule, allocation of risks and responsibilities, and any other requirements of the bid's document. If, after evaluating the price analyses, department determines that the bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Prasar Bharati may reject the bid/proposal.

Scope of work

Providing of inverter based circuit for lighting at HPT Bantalab in following rooms / hall:

- 1. HTVCB Room
- 2. LT Panel Room
- 3. Workshop cum Tool Almirah Room
- 4. Old BBC Transmitter space presently being used as Engineering room (Adjacent to existing Transmitter Control room.
- 5. The scope of the work includes lay a proper inverter lighting circuit in the above areas supporting a minimum of 30 lighting points (approx) and 04 power points (6amp) and 06 fan points. This shall require fresh wiring with switch sockets and holders and cable tray fittings etc.
- 6. The total length of the cable tray to be laid 50mm size on approximation basis shall be around 100 running mtrs.
- 7. The PVC cable tray has to be provided and fixed by way of 35mm screws in concrete cement walls after inserting 40mm Premium Nylon Plastic Self Prilling Drywall Anchors with Screws




