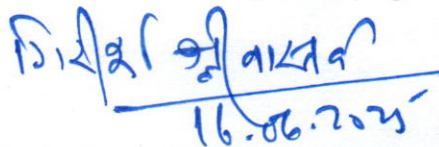

1. **Category:** Technical Interns
2. **No of Position:** 52 (Tentative)
3. **Place of work:** Akashvani & DD Kendras, North Zone, Prasar Bharati as detailed in the Annexure.
4. **Duration of engagement:** 1 Year
5. **Age:** Not exceeding 30 years as on the last date of submission of application.
6. **Consolidated Stipend:** Rs.25,000 per month
7. **Essential Qualifications.—**
 - a. Bachelor's or Master's Degree in Engineering in relevant streams such as Electronics, Telecommunication, Electrical, Civil, IT or Computer Science from a Government-recognized university/institution (approved by AICTE/UGC) with a minimum of 65% marks in relevant stream.
 - b. Fresh graduates/ Post Graduates or those who have completed their degree in the academic year (2024-25) are eligible. Candidates awaiting final results may apply with a certificate from the Head of the Institution, subject to fulfillment of the minimum marks criteria upon declaration of results.
8. **Nature of Duties:**
 - a. Assist in installation, operation, and maintenance of broadcast and IT equipment in Radio/TV stations, including studios, OB vans, and transmission sites.
 - b. Support daily technical operations such as signal monitoring, fault detection, live telecast support, uplink/downlink operations, and equipment troubleshooting.
 - c. Work with teams on technical planning for infrastructure development, studio upgrades and Civil/Electrical maintenance.
 - d. Assist in digital archiving, server management and software/hardware troubleshooting under IT operations.
 - e. Provide technical support for outdoor broadcasts, recce visits and special live events as assigned.
9. The terms and conditions of these engagements are as given under:
 - i. The services will be purely on contract basis. The persons engaged shall have no claim either implicit or explicit, for his/ her absorption or regularization in Prasar Bharati.

- ii. The person will be engaged on full time basis and will not be allowed to take up any other assignment during the period of contractual engagement.
 - iii. Persons engaged on contract basis can be assigned additional task apart from the specific tasks for which they are engaged.
 - iv. The engagement can be discontinued/ terminated with one- month notice or one month's salary in lieu thereof by either side without assigning any reason.
 - v. No claim of pensionary benefit on account of this contractual engagement shall be admissible.
 - vi. Prasar Bharati reserves the right to conduct test and/ or interview of the shortlisted candidates. No TA/DA etc. will be paid for attending the test/ interview.
