Subject: Entry of GST-related data in Prabhakar for ITC under BIND Procurement

It has come to the notice of the undersigned that in spite of clear instruction from B&A division through circular dated.07.02.2025, few PAOs are not entering data related to BIND Procurement in the in-house Prabhakar software of Prasar Bharati. This has resulted in blockage of ITC pertaining to FY 2024-25 to the tune of crores of rupees and posed a threat of huge loss if ITC is not availed in due time.

In this regard it is clarified that Prabhakar is not a portal of GST department but an internal arrangement of PB to facilitate SNOs of all states to claim ITC through entries made by the payment authorities within it's GST registration. Accordingly instruction was issued for all PAOs to make entry in Prabhakar against invoices for which they the payment authority.

The bills submitted by the DDO (zonal office) shall be duly paid by the PAO and after making payment, the GST details shall be uploaded by the PAO in Prabhakar portal so that there is no ITC loss to Prasar Bharati. As we are already in the process of migration of Prasar Bharati Accounts from CAS to Tally, therefore, the GST details has to be uploaded by the PAO in PB with immediate effect. For all the payments made from 1st April 2025 onwards, the GST details may be uploaded in the Prabhakar without fail.

However, there will be no change in TDS challan generation process and the same will continue to be done, as it was being done prior to issue of circular dated.07.02.2025.

All PAOs under Prasar Bharati are once again directed to make necessary entry of invoice details against BIND procurement for the FY 2025-26 immediately in Prabhakar against the respective GSTINs of the concerned SNOs.

If there is any ITC loss because of non-uploading of GST details in the Prabhakar, the concern PAO by name shall be held responsible.
