#### **Technical Specification for supply of Digital Audio Workstations**

#### 1. GENERAL

- **1.1** This specification is for Supply of Audio workstations at 47 Akashvani Stations.
- 1.2
- 1.2.1 The Hardware from OEMs having ISO certifications should only be offered. Hardware from hardware Integrators will not be accepted.
- 1.2.2 Workstation OEM should have authorized service centers in major cities across the country. List of Service Center along with their addresses, Telephone Numbers & E-mail addresses should be provided along with Tender Document.
- 1.2.3 Workstation OEM should have supplied at least 600 workstations per annum in last three years.
- 1.3 All the quoted products should be of field proven technology & OEM of the product should be in business for at least last five years.
- **1.4** The tenderer must submit the following documents along with the tender:
  - (a) A Clause-by-clause compliance statement as per format in Annexure-III, highlighting deviations, if any, on all the clauses of specification from OEMs of the offered products duly signed in original. If compliance statement is incomplete or in a format other than that in **Annexure-III**, the tender shall be rejected outrightly.
  - (b) Detailed printed literature of the Hardware giving complete details of features and performance data.
  - (c) The quote should either be from the OEM or from their authorized representative/dealer. In case, the quote is from the authorized representative/dealer, a certificate in original from the OEM that the tenderer is the authorized representative/dealer for India should be enclosed with the tender.
  - (d) A copy of un-priced Bill of Material (BOM) as per Annexure-IV indicating make, model no., **complete configuration details of offered hardware**, system software etc. shall be quoted clearly. Any tender, showing ambiguity in above terms shall be treated as incomplete and will be rejected.
- 1.5 The tenderer will be required to demonstrate the functions of the tendered offered during technical evaluation in New Delhi. The tenderer will be required to arrange all necessary software & hardware for demonstration during technical evaluation. The demonstration of the system will have to be conducted with-in one month from the date

of issue of Call letter which will be faxed/emailed on given telephone number/Email address. Non-compliance of demonstration within the stipulated time will disqualify the tender.

- **1.6** Incomplete offers will be rejected out rightly.
- **1.7** The supply of equipment at all the stations will have to be completed within **4 (four) months** after the placement of firm order.
- **1.8** Quoted Workstation model should not be reaching End of Life for next three years. An undertaking to this effect from Hardware OEM shall be submitted along with Tender Document.

#### 2. SCOPE OF THE TENDER

- **2.1** The Scope of this tender is for supply of Digital Audio workstation.
- 2.2 The equipment shall be supplied to the concerned consignee directly. The list of consignees is given at Annexure-I
- 2.3 The Bill of Material giving item-wise requirement is given at Annexure-II.

#### 3. HARDWARE SPECIFICATION

#### 3.1 Hardware Requirements

- 3.1.1 The hardware as per Bill of Material (Annexure-II) shall be supplied at various Akashvani stations listed in Annexure-I.
- 3.1.2 The hardware should be able to operate on 230 V +/- 10% V, 48-52 Hz, single phase AC power supply.
- 3.1.3 All the drivers for hardware shall be supplied along with hardware.
- 3.1.4 Anti-virus software shall be licensed to "Akashvani". OS may either be Factory (Hardware OEM) preloaded (with Recovery Media/Disk) or Licensed to "Akashvani".
- 3.1.5 Operating Environmental conditions: The equipment shall be able to work without any problem in the following conditions:

Operating Temperature: From 10° C to 40° C

Operating Humidity : Up to 80% RH (non-condensing) at 30° C.

3.1.6 Storage Environmental conditions: The equipment should be able to withstand the following conditions while being stored:

Storage Temperature : From -10° C to 65° C Storage Humidity : From 5 to 95% humidity.

3.1.7 The system shall be used in the vicinity of high frequency & high Power Radio field. Therefore, the system shall conform to the protection requirements relevant to electromagnetic phenomena as per national/international standards.

#### 4. PRE-DISPATCH INSPECTION

- All the Hardware shall be put up for inspection in a lot. Out of the lot, 10% of workstations shall be randomly selected and inspected in detail. Rest of Hardware shall be accepted on the basis of OEM Test Certificates. Detailed inspection of (10% workstations) would comprise of complete testing as per Acceptance test Procedure (ATP). The pre-dispatch inspection shall be done by authorized representatives of Akashvani at supplier's premises in India before delivery. However, in case of FOB order, pre-dispatch inspection shall be carried out at OEM's premises.
- 4.2 An Acceptance Test Procedure (ATP) should be prepared by the tenderer and got approved from the indenter after the firm order is placed.
- 4.3 The tenderer will give a notice in writing to the indentor at least 4 weeks before the commencement of inspection. The tenderer shall provide all equipment, materials and manpower as may be required for performing various tests as per ATP. In case of inspection outside Delhi, the expenses on travel, accommodation and daily allowances for Akashvani's Inspecting Officers would be borne by Akashvani.

#### 5. INSTRUCTION MANUAL

**5.1** A softcopy of manuals on CD/DVD ROM Media shall also be provided to each consignee.

#### 6. AFTER SALES SUPPORT

Comprehensive onsite warranty shall be provided for trouble free operation of Digital Audio Workstation for a period of three years from the date of supply. The warranty of workstation shall not be void if the cabinet of workstations is opened for insertion of Audio Card and Digital I/O Cards.
