2. Terms & Conditions

1. Submission of Bids:

- Sealed bids should be addressed to **Deputy Director (Admn.-GA), Directorate General: Akashvani, Akashvani Bhawan, Sansad Marg, New Delhi - 110001.**
- Bids should be dropped in the **Tender Box** placed at **Room No. 247, 2nd Floor, Akashvani Bhawan**, latest by **3:00 PM on 29.09.2025.**
- Bids received after the due date and time will not be entertained.

2. Opening of Bids / Auction:

- The sealed tenders will be opened on **29.09.2025 at 4:00 PM** in the presence of the bidders or their duly authorized representatives, who wish to remain present.
- At the time of auction, the condition and location of goods along with the terms of sale will be announced again for the benefit of bidders.

3. Earnest Money Deposit (EMD):

- Each bid should be accompanied with an **EMD of ₹1,000/- (Rupees One Thousand only)** in the form of **Demand Draft/Banker's Cheque** drawn in favour of *PB, BCI, DG:AIR, New Delhi*, issued by any Nationalized Bank.
- Bids without EMD will be summarily rejected.
- Exemption from EMD will be applicable to bidders registered with the **Central Purchase Organization** or **NSIC**, upon submission of valid documentary proof.

4. Acceptance of Bids & Payment:

- Acceptance or rejection of bids will be announced **immediately at the time of auction**.
- The successful bidder shall be required to deposit **not less than 25% of the bid value as earnest money on the spot**, in cash or through Demand Draft/Deposit-at-Call Receipt (DACR) in favour of *PB, BCI, DG:AIR, New Delhi*.
- The balance amount, along with applicable **GST**, must be deposited **within 07 (seven) working days** from the date of acceptance, through Demand Draft/Banker's Cheque.
- Only upon full payment of bid value (inclusive of GST), the goods will be released to the successful bidder.

5. Delivery of Goods:

- The successful bidder shall take delivery of the goods **at his/her own cost and risk**, within **10 working days** after making full payment.
- No assistance in loading/transportation will be provided by this Directorate.

6. Auction Team:

- The auction will be conducted by a duly constituted in compliance with extant rules and guidelines.

7. General Conditions:

- The items are offered for disposal on *as is where is* basis and no guarantee regarding condition/fitness will be given.
