Application Periods:

- **1st November to 30th November**

Eligibility:

Candidates must apply at their respective **Doordarshan Kendra** where they are residing.

2. “Guidelines for Gradation & Audition of Dance Artists in Doordarshan” is enclosed and shall take effect from the date of issuance of this order.
3. Any gradation made prior to the issuance of this order shall remain unaffected.
4. It is advised that Head of Programme [HoP] of a Doordarshan Kendra may invite applications/request for gradation/upgradation within the following period from the perspective of standardization and uniformity:
 - a. From 1st April to 30th April of that respective year and/or
 - b. From 1st November to 30th November of that respective year.
5. This issues with approval of the Competent Authority.

Subject: Guidelines for Gradation & Audition of Dance Artists in Doordarshan

In supersession of all previous guidelines/instruction regarding gradation/upgradation of Dance Artists by Doordarshan, the following guidelines may be followed:

1. Application Procedure:

- a. Applicants must submit a duly filled Application form complete in all respects either online (through the Dance Audition Portal) or as a hard copy through speed post/courier/e-mail. The format for application form is annexed as **Annexure-I**.
- b. If the application form is being submitted as a hard copy then it should be submitted to the respective Kendra where the applicant intends to appear for the audition.
- c. Supporting documents like proof of age, certificate from Gurus/Institutions, press views etc. to be attached with the application form.
- d. If an applicant is desirous of being auditioned/gradation for more than one Dance form (**mentioned in Clause 4**), a separate application must be submitted for each style.

Note:- **As referred to in clause 1(a), the offline method for submission of applications will be discontinued once the Dance Audition portal becomes fully operational. Thereafter, application for audition will be accepted only through Dance Audition portal.**

2. Age Criteria for Grading & Upgrading:

The minimum age requirements of applicant are as under:

- a. For 'B' Grade – **18 years** and above.

- b. For '**B high**' Grade – **25 years** and above.
- c. For '**A**' Grade – **35 years** and above.
- d. For '**Top**' Grade – **40 years** and above.

3. Processing Fee for Applicant (Non – refundable)- For Gradation and Upgradation:

- a. Fee for '**B**' Grade - Rs. 2000/-
- b. Fee for '**B**' to '**B high**' grade - Rs. 3000/-
- c. Fee for '**B high**' to '**A**' grade - Rs. 4000/-
- d. Fee for '**A**' to '**Top**' grade - Rs. 5000/-

Applicants submitting their forms online (via Dance Audition Portal) must follow the payment instructions provided on the Portal. If application is being submitted as a hard copy to the Doordarshan Kendra, payment should be made as specified in the application form.

4. Dance forms for Audition:

(i). Existing Classical Dance forms for audition are:-

- a. Kathak
- b. Kathakali
- c. Odissi
- d. Bharatnatyam
- e. Mohiniyattam
- f. Kuchipudi
- g. Manipuri and
- h. Sattriya.

(ii). Other important Dance Traditions and Folk/Tribal dances of India are also eligible for audition. The decision for

their eligibility will be decided in consultation/coordination with Sangeet Natak Akademi in Delhi. Doordarshan Kendras may also consult/ coordinate with regional and state-level cultural bodies or the regional/state Sangeet Natak Akademi for inclusion of any dance form before recommending the same before DG, Doordarshan for approval.

5. General Guidelines for Auditioning of 'B' Grade Artists:

- a. Each Doordarshan Kendra will have a Local Dance Audition Committee (LDAC) to conduct auditions for **Grade 'B'** only.
- b. The Local Dance Audition Committee will recommend the grade to the artist/applicant appearing for the audition on the basis of the performance quality and visual presentation.
- c. The recommendation of LDAC to be placed before the concerned Head of Programmes (HoPs) for approval.

6. Local Dance Audition Committee (LDAC):

I. Composition:

- a. Head of Programme [HoP] of the concerned Doordarshan Kendra or his/her representative.
- b. Two non-official members who are experts and knowledgeable in the respective field of specialization.
- c. The Programme Officer looking after the Dance programmes at the Kendra

Note:- Head of Programme [HoP] of the respective Doordarshan Kendra or his nominee will be the Chairman while the Programme Officer looking after the Dance programmes will be Convenor of the Local Dance Audition Committee.

II. Non-Official Members Of Local Dance Audition Committee (LDAC):

- a. The Dance Section at the Kendra shall maintain a sufficiently large panel of experts and knowledgeable persons to ensure availability of non-official members for auditions

- b. The term of non-official experts on the panel will be for a period of two years from the date of his/her nomination however they shall be eligible for re-nomination.
- c. The non-official experts of the Committee will be approved by the Director General, Doordarshan taking into consideration, the recommendations of Head of Programme [HoP] of the concerned Doordarshan Kendra.
- d. Doordarshan Kendra will ensure that the two non-official members should not be affiliated to the institution/organization of the appearing candidate at that time.
- e. An undertaking must be obtained from the two non-official members by the **Doordarshan** Kendra regarding non-affiliation as mentioned above and any other conflict of interest.

III. Procedure to be followed by Local Dance Audition Committee (LDAC) for selection of 'B' Grade Artists:

- a. Auditions will be held at the respective Doordarshan Kendras.
- b. The Doordarshan Kendra will make suitable arrangements for the audition.
- c. Head of Programme [HoP] will send all correspondence to the candidates and to the members of LDAC in connection with the auditions.
- d. Graded Artists may be given an opportunity to showcase their talent on Doordarshan's platform by Kendra as and when required.

IV. Functions of Local Dance Audition Committee (For 'B' Grade):

- a. The Local Dance Audition Committee will conduct audition at least twice in a year or as and when required.
- b. The discussions, proceedings and observations of the Local Dance Audition Committee will be treated as confidential.
- c. The non-official members of the Committee will not enter into any correspondence with the candidates.

- d. In case of any dispute related to the gradation, the matter will be referred to the Director General, Doordarshan for final decision.

V. Procedure For Audition:

- a. Applicant auditioning for B Grade will be assessed on the basis of live performance either on live music or pre-recorded music.
- b. In exceptional circumstances, auditions may be conducted via web based platform. However, for audition live performance (either on live music or pre-recorded music) of applicant is required. LDAC will record the reason for such exception.
- c. Candidates must perform for at least 15 minutes which will include two segments as below:

S.No	Segment	Minimum Duration
i.	Abhinaya (expressive dance)	7 minutes and 30 seconds
ii.	Nritta (technical dance)	7 minutes and 30 seconds

- d. The recording of the candidate will be done in a single take, without any editing.
- e. The recording will be done on the set of **Black Cyclorama/Black background**.
- f. For each audition session, every member of LDAC will be provided with an assessment form wherein he/she should give his/her assessment and remarks on various aspects including performance and presentation of the candidates, as per the format at **Annexure-II (a) & (b)**.
- g. The successful applicants will awarded a certificate of gradation.

7. Upgradation Process ('B' to 'B' high, 'B high' to 'A' and 'A' to 'Top' Grade):

I. Application:

Dance Audition Board at Directorate General : Doordarshan (DG: DD).

II. Central Dance Audition Board (CDAB):

(A) Composition:

- a.** An Officer nominated by Director General on the recommendation of Programme officer in charge of Music & Dance Section at DG:DD.
- b.** Two non-official members who are experts and knowledgeable in the respective field of specialization nominated by Director General on the recommendation of Programme officer in charge of Music & Dance Section at DG:DD.
- c.** Programme officer in charge of Music & Dance Section at DG:DD or his nominee who shall also be the convener.

(B) The recommendation of Central Dance Audition Board (CDAB) to be placed before Director General, Doordarshan for approval. The decision of Director General, Doordarshan will be treated as final.

(C) The CDAB will decide about following upgradations:

(i). 'B' to 'B high' grade

(ii). 'B high' to 'A' grade

(iii). 'A' to 'Top' grade

III. The upgradation of the applicants by the Central Dance Audition Board should be conducted at normally least once in a year.

IV. Procedure for Upgradation of Artists:

- a.** The Central Dance Audition Board (CDAB) will evaluate applicant assessing the recorded performance of at least 15 minutes of two segments as below:

- b. The recording of the candidate will be done in a single take, without any editing.
- c. The recording will be done on the set of **Black Cyclorama/Black background**.
- d. The recording of the performance and hard copy of the documents should be forwarded by the respective Doordarshan Kendras to Programme Officer in charge of Music & Dance Section at DG:DD.
- e. For each audition session, every member of CDAB will be provided with an assessment form wherein he/she should give his/her assessment and remarks on various aspects including performance and presentation of the candidates, as per the format at **Annexure-II (a) & (b)**.
- f. The successful applicants will be awarded a certificate of gradation.

8. Exemption/ Relaxations to the Artists for Gradation/ Upgradation:

- a. The Director General, Doordarshan, may grant exemption/relaxation from the routine audition process for gradation or upgradation to certain categories of artists on the recommendation of CDAB, if a request has been made by an artist.

b. Categories eligible for Exemptions/Relaxations:

- i. **Award Winners** – National Awards(Conferred by Union Government), Padma Awards, Sangeet Natak Akademi Awards, State Government Awards (Conferred by State Government), State Sangeet Natak Akademi awards in the field of dance.
- ii. **Traditional Gharanas:** Stake Holders of the Legacy traditions (Gharana)

- iii. **Renowned Performers:** Artistes with recognised National & International Performances

c. Criteria for Age and Experience for artists considered for Exemption/Relaxation:

- d. The exempted artist/applicant will provide a recording of their performance of at least 15 minutes duration, not older than 6 months to be placed for consideration. A non-refundable processing fee of Rs. 10,000/- is required to be paid by the artist/applicant for consideration under the exemption clause.

9. Payment of honorarium and TA/DA to the non-official expert members of Local Dance Audition Committee (LDAC) and Central Dance Audition Board (CDAB):

- a. For attending the audition sessions, the non-official members of the LDAC and CDAB will be entitled to honorarium, travelling allowance and daily allowance etc. as per prevailing Doordarshan Rate Card.

- b. Members of Parliament serving as Members of LDAC and CDAB shall not be entitled to any honorarium for conducting auditions or to any sum of money other than compensatory allowance as defined in S.2 (a) of the Parliament (Prevention of Disqualification) Act, 1959.

10. Miscellaneous:

- a. An applicant/artist who has not been found suitable for desired gradation/upgradation can reappear for audition after the expiry of one year from the date of his/her last audition.
- b. The Director General, Doordarshan may at his/her discretion or on the recommendation of the Head of the programme of Doordarshan Kendra / Programme officer in charge of Music & Dance Section at DG:DD , can make an exception in special cases to reduce the prescribed time limit for re-audition.
- c. A consolidated database containing details of all the graded Artists and their gradation years etc. will be maintained by respective Doordarshan Kendra as well as be forwarded by Head of the programme of Doordarshan Kendra to Programme officer in charge of Music & Dance Section at DG:Doordarshan for uploading the same on the Prasar Bharati/Doordarshan website for transparency and public information.
- d. All disputes regarding auditions or gradation shall be resolved by the Director General, Doordarshan, whose decision shall be final.
- e. In case of any difference of opinion regarding the interpretation of these rules, matter may be referred to Director General, Doordarshan through Programme officer in charge of Music & Dance Section at DG:Doordarshan. The decision of Director General, Doordarshan will be final.
- f. Notwithstanding anything mentioned in these document/guidelines, DG, Doordarshan may modify any of the provisions mentioned in this document/guidelines and may grant exemption from any of its provision(s).
