2. The competent authority on behalf of the President of India does not bind himself to accept the lowest or any other quotation and reserves to himself the authority to reject any or all the quotations received without assigning any reason. All quotations, in which any of the prescribed conditions are not fulfilled or any condition including that of conditional rebate is put forth by the bidder shall be summarily rejected.
3. Any claim of whatsoever nature shall not be entertained.

CONDITIONS OF THE CONTRACT :

1. The work shall be carried out as per CPWD Specifications, 2019 Vol. I & II with upto-date correction slips and as per directions of Engineer-in-Charge;
2. Time limit for completion of work is **1 (One) month**.
3. Quoted rates are inclusive of all taxes and levies payable under the respective statutes including GST, nothing extra will be paid on any account;
4. No extra payment shall be made on any account such as extra thickness of base coarse/depths and all height of buildings, etc.;

5. All type of security measures / precautions of labour shall be responsibility of agency during execution of work. No extra payment will be made on any account;
6. If the work is prolonged beyond stipulated time the penalty shall be imposed @ ` 2,500.00 per week;
7. The agency will be responsible for any defect for a period of 12 (twelve) months after issuing completion certificate for the work by Engineer-in-charge & client department. If any defect found during the defect liability period, the agency shall rectify the same within 7 days after receiving the notice from Engineer-in-charge in any form failing which the defective work shall be got rectified / replaced completely at the risk & cost of the agency and no claim whatsoever shall be entertained in this regards. The agency may note that the recovery shall be made from any of the payments due with the department or will be under legal obligation to refund the cost incurred by department in rectification / replacement of the defective work came to the notice of Engineer-in-charge during defect liability period.

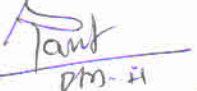

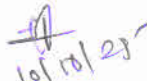
