Qualification - Should have passed CMA Intermediate Examination conducted by Institute of Cost Accountants of India (ICAI) with at least 50% marks.

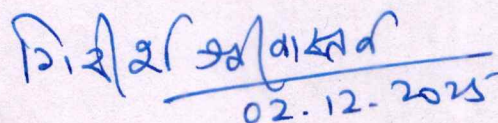

- The training period of Cost Trainees at Prasar Bharati would be extended for subsequent year based on yearly appraisals.
