**A) Eligibility Criteria / Experience of work: -**

a) Agencies having successfully completed similar works during last seven years ending up to previous month of last date of submission of tender as given below with completion certificate issued by an officer not below the rank of Executive Engineer or equivalent of a Govt. Department PSU / Autonomous body, duly attested, otherwise TDS Certificates is required against the eligible work:

1. Three similar completed works each of value not less than 40% (Rs. 1.18 Lakhs) of the estimated cost put to tender. OR
2. Two similar completed works each of value not less than 60% (Rs. 1.77 Lakhs) of the estimated cost put to tender. OR
2. One similar completed work of value not less than 80% (Rs. 2.36 Lakhs) of the estimated cost put to tender.

b) Similar work shall mean "Setting up of 10KW (1+1) VHF FM Solid State Broadcast Transmitter at DD site, SHIVAMOGGA (Karnataka). SH: Augmentation of illumination by providing additional Street Lights and Flood Lights for Transformer Yard, front & rear side of Transmitter building i/c Cable laying, Focus Lights for the Name Board, Rewiring of Sentry Post etc.) The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to previous day of last day of submission of bids.

Full credentials of the project authorities e.g. email, ID, complete postal address, Phone no. etc. are required for verification purposes.)
4. Electrical Inspectorate certificate.
5. Copy of Certificate of Registration for GST (Certificate of Registration for GST and the GSTIN should be active on GST portal on the date of opening of bids)
6. latest GST returned in Annexure – 3B.
7. Partnership deed (if required).
8. Affidavit as per para 1.2.2 of CPWD and name of work to mentioned above the content of the affidavit.
9. EMD affidavit on non-judicial stamp paper of Rs. 100/- duly notarized in original and name of work to mentioned above the content of the affidavit
