Terms and Condition:-

1. The work shall be carried out as per CPWD specification with up to date correction slip.
2. No material will be issued by the department.
3. Time of completion of work is **1 (One) Month**.
4. Payment shall be made as per actual execution of work.
5. No advance/mobilization advance will be given to the agency.
6. Bidder must ensure to quote rate of each item. If any cell is left blank and no rate is quoted by the bidder, rate of such item shall be, treated as "0" (ZERO). The work is of urgent in nature. The contractor intending to participate must complete the work in time otherwise he need not apply.
7. Interested bidders shall be required to submit copy of all documents such as registration, up to date GST return, work experience required for issue of quotation paper along with original documents for verification. Original documents shall be returned after verification.
8. The bidder should possess certificate of registration for GST.
9. The rates to be quoted by the bidder shall be firm and inclusive of all taxes.

10. The bidder shall ensure that benefit of input tax credit (ITC) of GST on materials likely to be availed by them is duly considered while quotation rates.
11. Income tax, TDS towards GST, Labour Cess & other statutory deduction etc. shall be made at source as per the prevalent laws.
12. Intending bidders are advised to inspect and examine the site and its surrounding and satisfy themselves before submitting their quotations as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their quotation / bid. A quotationer / bidder shall be deemed to have full knowledge of the site whether he inspect it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The quotationer / bidder shall be responsible for arranging and maintaining at his own cost all material, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a quotation by a quotationer / bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specification of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.
