

- 3) The quotations will be opened in the presence of the undersigned at 11.30 hours on 02.03.2026 in the presence of such tenders or their agents as may choose to attend.
- 4) **The quotations submitted should remain open for acceptance for a period of one year from the date of opening them.**
- 5) All the material for works will be supplied by the Firm/ contractor. The work will have to be completed within 15 days' time by the firm as and when from placement of work order.
- 6) Tenders/quotations in which transit Insurance has been specified as an additional item of expenditure is liable to be ignored.
