3. The duly filled in application along with the required documents may be emailed at ddfreesish@prasarbharati.gov.in latest by **31st March (Tuesday) 2026 by 05.00 P.M.** Applications already received from TV channels in the interim period will also be considered for placement on WAVES OTT.

4. All other terms and conditions as provided in the original Notice No. OTT/2(02)/2024/Platform/529, dated 17.11.2025 shall remain unchanged.

Subject: Notice Inviting Applications for on-boarding linear satellite TV channels for streaming on WAVES OTT Platform.

1. Prasar Bharati invites applications for on-boarding permitted/licensed linear satellite TV channels for streaming on Prasar Bharati's OTT Platform, WAVE, for a period of one year from the date on which the channel is placed on the WAVES platform.
2. Only satellite channels, permitted/licensed by the Ministry of I&B for downlinking/distribution in India under relevant guidelines are eligible for streaming on WAVES OTT platform.
3. Only companies holding valid permission/license from Ministry of I&B for downlinking/distribution of satellite TV channel can apply for in respect of their own channels for on-boarding on WAVES Platform.
4. Broadcasters desirous to place channels on WAVES will be required to provide SCTE-35 /ad marker enabled feed of channel, which can signal the start and end times of advertisements breaks, of the channel.
5. The clean feed of successful channel will be carried on WAVES on revenue sharing basis which will be in the ratio of 65:35 of the net revenue generated from the channel by inserting advertisements (65% to channel & 35 % to Prasar Bharati).
Net revenue for this purpose is defined as revenue earned from the channel after adjusting all costs borne by Prasar Bharati for the respective channel such as transcoding cost, CDN cost, commission of the Ad agency hired for Ad insertion.
6. Advertisements on WAVES stream will be inserted by Prasar Bharati, at appropriate juncture of the stream as per the availability of SCTE-35 marker. If Prasar Bharati is not able to fill the entire ad duration, the left over duration will be utilised for promos of Prasar Bharati and the respective streaming channels.
7. Broadcasters desirous of streaming their channel(s) on WAVES are required to provide clear and unambiguous proof in support of genre & language classification of their channel. In case of lack of clarity, ambiguity or conflicting information, applications will be deemed ineligible and may be summarily rejected.
8. All applicant TV channels will be ranked on the basis of DAVP rates card. The selection criteria will be on the basis of the highest rate of a channel under all the time bands, among each of the above categories. Channels having highest rates as per DAVP rates card, in the respective category, shall be selected for streaming on OTT Platform.



9. Interested broadcasters may apply in the prescribed application form given at **Annexure-1** along with all requisite documents as prescribed in the **Annexure-2**.
10. The duly filled in application along with the required documents as mentioned in the Annexure-2, may be emailed at ddfreesish@prasarbharati.gov.in latest by **1st December (Monday) 2025 by 05.00 P.M.**
11. For detailed terms & conditions, selection process etc. please refer to clause 11.2 (*Streaming Collaboration with Satellite Channels and FAST Channels*) under chapter 11 of 'Prasar Bharati's Content Sourcing Policy 2024' which is available on the Prasar Bharati website, <http://prasarbharati.gov.in>.
12. A 'Letter of Allotment' will be issued by Prasar Bharati to successful channels.
13. Every successful channel will be required to sign an 'Agreement' with Prasar Bharati in two original copies within 15 days of issue of 'Letter of Allotment', a copy of which is attached herewith for reference.
14. Successful Channels will be required to provide such technical details as required for on-boarding the feed on OTT Platform.
15. The Last Date for submission of applications is **1st December (Monday) 2025 by 05.00 P.M.**

 - iii. Documentary evidence from Television rating Agency (eg: BARC) that could clearly establish their genre & language classification.
