A) Eligibility Criteria / Experience of work: -

a) Agencies having successfully completed similar works during last seven years ending up to previous month of last date of submission of tender as given below with completion certificate issued by an officer not below the rank of Executive Engineer or equivalent of a Govt. Department PSU / Autonomous body, duly attested, otherwise TDS Certificates is required against the eligible work:


1. Three similar completed works each of value not less than 40% (Rs. 2.80 Lakhs) of the estimated cost put to tender. OR
2. Two similar completed works each of value not less than 60% (Rs. 4.20 Lakhs) of the estimated cost put to tender. OR
2. One similar completed work of value not less than 80% (Rs. 5.60 Lakhs) of the estimated cost put to tender.

b) Similar work shall mean "**Maintenance of Electrical Installation and Fans for AIR Bengaluru for the year 2026-2027 SH: Providing services of Wireman and**

Khalasi.]" The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to previous day of last day of submission of bids.

List of documents to be scanned and uploaded within the period of bid submission:

1. Copy of Account Payee Demand Draft/Bankers Cheque/Fixed Deposit Receipt from any of the Commercial banks or Insurance Surety Bonds against Earnest Money Deposit [Must be submitted as a single instrument].
2. Enlistment Order of the contractor.
3. Certificate of eligible similar nature of works satisfactorily completed during the last seven years ending previous month of last day of submission of tenders should have been issued by an officer not below the rank of Executive Engineer / Project manager or equivalent. (To avoid delays in getting the completion cost verification from the project authorities, TDS certificate including BOQ of Final bill is desired, but not essential for tendering purposes. Full credentials of the project authorities e.g. email, ID, complete postal address, Phone no. etc. are required for verification purposes.)
4. Electrical Inspectorate certificate.
5. Copy of Certificate of Registration for GST (Certificate of Registration for GST and the GSTIN should be active on GST portal on the date of opening of bids)
6. latest GST returned in Annexure – 3B.
7. Partnership deed (if required).
8. Affidavit as per para 1.2.2 of CPWD and name of work to mentioned above the content of the affidavit.
9. EMD affidavit on non-judicial stamp paper of Rs. 100/- duly notarized in original and name of work to mentioned above the content of the affidavit
