

## TERMS AND CONDITIONS

- The manpower shall perform duties during normal office working hours or as instructed by the office authority.
- Valid GST registration must be provided.
- The contractor shall provide qualified and experienced personnel as required by the office.
- All staff must be physically fit, disciplined, and of Good conduct.
- The contract shall initially be valid for 1 year (or as decided by the authority).
- The contractor must comply with all **labour laws**, including: Minimum Wages Act, EPF & ESI contributions, Payment of Wages Act, Contract Labour (Regulation & Abolition) Act.
- The contractor shall be responsible for payment of salary, insurance, and other benefits to employees.
- If any manpower is found unsatisfactory, absent, or involved in misconduct, the contractor must replace them immediately without extra cost.
- The manpower must maintain confidentiality of official records and information.
- If manpower is not provided as per requirement or remains absent, penalty may be deducted from the contractor's payment.
- Repeated negligence may lead to termination of contract.
- The contract may be terminated by either party with 30 days written notice. Immediate termination may occur in case of serious violation of terms.
- The contractor shall be responsible for any damage, loss, or misconduct caused by the deployed manpower.
- Payment will be done on Monthly basis; Contractor must have at least one month's expenditure as cash-in-hand, to enable him to pay the salary to staff deployed, in case of administrative delay, if any.
- The monthly bill will be accepted only along with the work completion certificate from the station Incharge.
- Rates should be mentioned in word and figures also.
- Printed terms and conditions on the letter heads of tendering firms will not be considered as forming part of the tender. Conditions applicable should be specifically stated.
- **TERMS OF PAYMENT:** 100% payment will be made within 60 days from the date of receipt of satisfactory work done certificate from concerned official or the date of receipt of bill, whichever is later.
- The quotations submitted should remain open for acceptance for a period of *ONE* Year from the date of opening them.
- **RIGHT OF ACCEPTANCE:** - This office reserves the right to reject the lowest tender or any or all the tenders without assigning any reason whatsoever.
- Income tax TDS & GST TDS each @ 2% of tendered amount will be deducted for works worth of Rs. 1,50,000/- and 2,50,000/- respectively in a year.
- Submission of the tender implies that the bidder accepts all terms and conditions mentioned in the tender document.
