1. Introduction

PrasarBharati, Akashvani, Hyderabad invites Expressions of Interest (EOI) from reputed agencies for development, installation, operation and maintenance of Digital LED Unipole Advertisement Structures at identified sites of Akashvani Hyderabad under a Public-Private Partnership (PPP) model.

The selected agency shall invest, construct, operate, maintain and commercially utilize the Digital LED Unipoles while sharing revenue with Prasar Bharati as per mutually agreed terms.

2. Objective

The objective is to:

- Monetize available Prasar Bharati land assets. .
- Improve urban outdoor media infrastructure.
- Promote Government campaigns through digital displays.
- Develop aesthetically designed digital advertising infrastructure.

3. Scope of Work

The selected agency shall:

1. Conduct site survey and feasibility assessment,
2. Prepare structural design.
3. Obtain statutory permissions from GHMC or equivalent authorities
4. Fabricate and install Digital LED Unipole.
5. Provide electrical infrastructure.
6. Install required controllers and communication systems.
7. Operate advertisement content.
8. Maintain equipment throughout contract period.
9. Ensure structural safety.
10. Obtain insurance.
11. Share the agreed annual revenue with Prasar Bharati and provide 33% of the total display time in all time bands, free of cost, for Prasar Bharati and Government advertisements.

Detailed Scope of Work

1. The SITC of Unipole hoardings at the given location along with the operation and maintenance of said Unipole.
2. The agency will obtain the right to display the advertisement on LED Unipole Street Hoardings after the fulfillment of all clauses laid down in the tender.

3. The agency shall make necessary arrangement to get permissions for Digital Outdoor Advertising and electricity connection from respective Authorities/service providers towards display and illumination of the LED Monopole Street Hoardings and shall bear the necessary charges towards consumption of electricity.
