### NOTICE INVITING QUOTATION

The Executive Engineer (Civil), Civil Construction Wing, Akashvani, Mumbai-20, on behalf of the President of India invites quotations in sealed covers from approved and eligible contractors of C.P.W.D. and those on appropriate class of contractors enlisted in the Department of Telecommunications (BSNL / MTNL), Department of Post, M.E.S., Railways, State P.W.D. of Maharashtra as well as eligible Civil working contractor of CCW : Akashvani for the following work, upto 1500 hrs. on 11-06-2026 which shall be opened on the same day at 1530 hrs. in the presence of intending bidders.

Blank quotation shall be issued to the agency on submission of application with definite proof having executed civil work, GST registration no. and acknowledgement of upto date GSTR1 returns.

Name of work : Providing and fixing aluminium partition near lift lobby for 9<sup>th</sup> floor guest house, plumbing fittings, providing & fixing aluminium sheet to wall & beam for water leakage arresting at terrace at Phase-II NFDC (FD Complex) Pedder road Mumbai-26.

2. The competent authority on behalf of the President of India does not bind himself to accept the lowest or any other quotation and reserves to himself the authority to reject any or all the quotations received without assigning any reason. All quotations, in which any of the prescribed conditions are not fulfilled or any condition including that of conditional rebate is put forth by the bidder shall be summarily rejected.
3. Any claim of whatsoever nature shall not be entertained.

#### CONDITIONS OF THE CONTRACT :

1. The work shall be carried out as per CPWD Specifications, 2019 Vol. I & II with upto-date correction slips and as per directions of Engineer-in-Charge;
2. Time limit for completion of work is **1(One) month**.
3. Quoted rates are inclusive of all taxes and levies payable under the respective statutes including GST, nothing extra will be paid on any account;
4. No extra payment shall be made on any account such as extra thickness of base coarse/depths and all height of buildings, etc.;

5. All type of security measures / precautions of labour shall be responsibility of agency during execution of work. No extra payment will be made on any account;
6. If the work is prolonged beyond stipulated time the penalty shall be imposed @ ` 2,500.00 per week;
7. The agency will be responsible for any defect for a period of 12 (twelve) months after issuing completion certificate for the work by Engineer-in-charge & client department. If any defect found during the defect liability period, the agency shall rectify the same within 7 days after receiving the notice from Engineer-in-charge in any form failing which the defective work shall be got rectified / replaced completely at the risk & cost of the agency and no claim whatsoever shall be entertained in this regards. The agency may note that the recovery shall be made from any of the payments due with the department or will be under legal obligation to refund the cost incurred by department in rectification / replacement of the defective work came to the notice of Engineer-in-charge during defect liability period;
8. The Contractor is required to furnish a Guarantee Bond, on stamp paper of appropriate value, in the proforma attached, as guarantee for the Integral water proofing / APP sheet treatment /aluminium sheet / coating / painting of entire roof, chajja, sump well/OHT, external wall / beam surface and other portions of the building, etc. as the case may be. Period of this Guarantee shall be 5 (Five) years to be reckoned from the date after the maintenance period prescribed in the contract Agreement. In addition to the above, 10% (ten percent) of the cost of the water proofing item/s shall be retained as guarantee money to watch the performance of the work done. However, half of the amount so retained would be released after three years and the balance after five years, if the performance of the work is found satisfactory. If any defects is noticed during the guarantee period, it should be rectified by the contractor within seven days of a Notice from the Department, and if not, the same will be got done through another agency at the risk and cost of the contractor.
