

5. No advance payment will be made in any circumstances and payment will be made only on presentation of bill after the satisfactory completion of the work.
6. This Organisation may reject/accept or prefer any tender without having to assign any reason whatsoever. This Organisation also reserves to itself the right to accept any tender in part or split the order between two or more bidders.
7. In case certain clarifications are sought by this Organisation after opening of tenders, then the reply of the bidder should be restricted to the clarifications sought.
